GHANA STOCK EXCHANGE



HIGHLIGHTS: The Prime Index(GSE-CI) jumps 12.64 points to 3,788.84 points; returns 21.04% YTD.

The benchmark index of the Ghana Stock Exchange (GSE Composite Index) advanced by 12.64 points to close at 3,788.84 points returning 21.04% YTD. The GSE Financial Stocks Index however closed unchanged at 2,097.73 points and a YTD return of 10.32%.

The price movers on the day were ALLGH, GGBL, UNIL, and GLD which closed at GH¢4.62, GH¢4.40, GH¢13.43 and GH¢343.75 respectively. As a result, the market's total value advanced by GH¢147.53 million to reach GH¢84.53 billion.

In terms of trade activity, total turnover grew to GH¢ 648,981.53 (up 171.24%) compared to the previous day. Thirteen (13) different equities were traded as total volumes traded dropped, with 79,322 shares traded.

There were outstanding offers for FML, SOGEGH and UNIL at GH¢3.19, GH¢1.55, GH¢12.50 respectively.



SUMMARY: MAY 2024 MARKET ACTIVITIES

The GSE Composite Index gained 66.60 points in May 2024 (returning 19.91% YTD, compared to 2.76% for the same period last year). The GSE financial stock index also rose by 8.34 points to place its YTD gain at 7.95%. Volumes traded recorded a substantial jump of 622.01%, with a turnover of 260.52% over the month of May. The top price gainers for the month were GLD (12.61%), GCB (8.06%), MTNGH (2.86%) and TOTAL (1.58%). CAL, BOPP, FML and SIC lost 7.89%, 0.19%, 0.31% and 4.00% of their market prices respectively.
