(RBGH), which gained GH¢0.05 to close trading at GH¢0.60 followed by Enterprise Group Limited (EGL) which gained a pesewas to close at GH¢2.51.

Market Capitalization thus increased by GH¢44.30 million to close trading at GH¢64.18 billion representing a growth of 18.04% in 2021.

A total of 270,832 shares valued at GH¢324,667.35 were traded between ten (10) equities with Scancom PLC. (MTNGH) regaining the top spot as the most traded stock, accounting for 92.09% of the total volume and 92.18% of the total value traded.


