

EQUITY MARKET HIGHLIGHTS: GSE-CI lost 0.19 points to close at 2,698.88; returns -3.24% YTD.

After two trading days of remaining unchanged, the benchmark GSE Composite Index (GSE-CI) today decreased by 0.19 points to close at 2,698.88 representing a YTD return of -3.24%. The GSE Financial Stock Index (GSE-FSI) also lost 0.34 points to close at 2,223.67 representing a YTD return of 3.34%.

In the aggregate, thirteen (13) equities participated in trading, ending with only one decliner namely SIC Insurance Company Ltd. (SIC) as it lost GH¢0.01 to close at GH¢0.25 representing a YTD gain of 212.50%. Market Capitalization for the day settled at GH¢64.06 billion.

A total of 159,521 shares valued at GH¢81,323.10 was traded on the day with Scancom PLC. (MTNGH) recording the largest share of trades per value as it accounted for 42.16% of the total value traded.


