



Daily Stock Market Recap: February 27, 2020

Market Highlights

- Losses in four counters in the banking and consumer goods sectors dragged the benchmark index down by 0.15% to close at 2,177.11 with a -3.55% year-to-date return while market capitalization declined by 0.06% to settle at GHS56.18 billion.
- The GSE-FI declined by 0.28% due to losses in **GCB Bank Ltd** (-0.21%), **Standard Chartered Bank** (-0.37%) and **Cal Bank Ltd** (-3.23%) to close at 1,964.56 with a -2.73% ytd return.

Activity Levels Increased

- Trading activity increased as 800,452 shares valued at GH¢565,907 changed hands compared with 544,753 shares valued at GH¢523,749 yesterday.
- CAL Bank Ltd** dominated trades for the second straight session, accounting for 56.27% of total value traded.

Outlook

- We expect trading activity to pick up as companies release audited 2019 annual results.

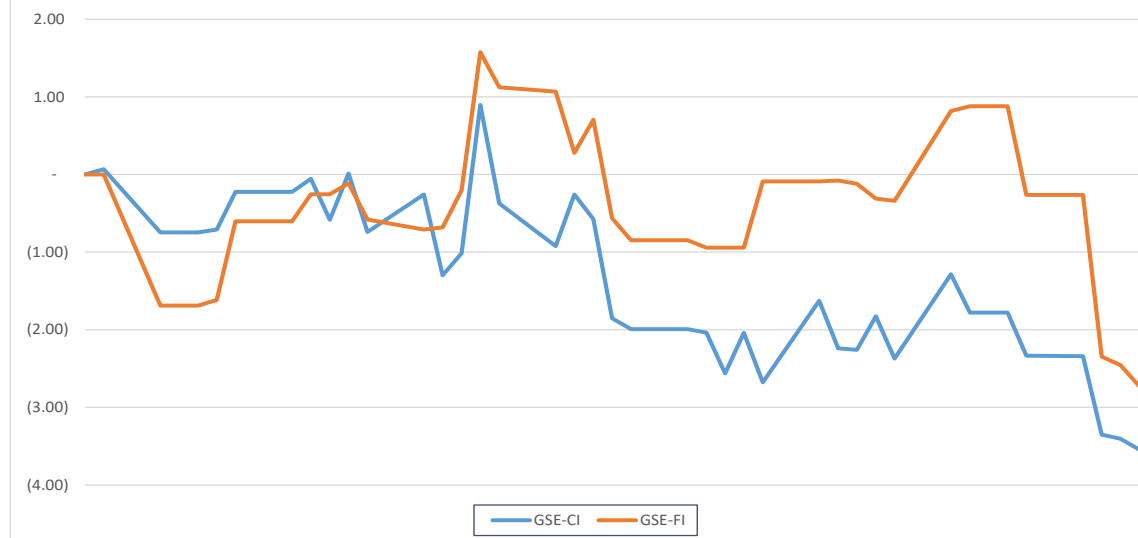
