

# EQUITY MARKET HIGHLIGHTS: Benchmark GSE-CI records no change; returns 39.70% (YtD)

The Benchmark Index (GSE-CI) flattened as there were no gainers or decliners at Thursday's trading session to close at 2,712.37 translating into a YtD return of 39.70%. The GSE Finance Stock Index (GSE-FSI) also remained unchanged to close at 1,890.15 representing a YtD return of 6.02%. Market Cap. remained unchanged at GH¢62.19 billion.

Trade volume dropped significantly as 78,283 equities valued at GH¢98,327.05 exchanged hands in six (6) equities compared to 4,379,165 shares valued at GH¢8,829,456.60 traded at Wednesday's session.

Scancom PLC. (MTNGH) recorded the lion's share of trades for a second day running, accounting for 94.69% of total value traded.


