# FIXED INCOME MARKET UPDATE GEM

**HIGHLIGHTS:** Last week's auction saw total bids fall short of the target of GH¢6,669.00 million, representing a 17.96% undersubscription.

Total bids worth GH¢5,471.04 million were received across the three T-bill maturities, recording a 79.98% acceptance rate. The largest amount of GH¢2,652.90 million, was brought in from 91-day T-bill issuance, while GH¢1,674.14 million was brought in from 182-day T-bills. Also, the 364-Day bill had GH¢48.44 million worth of bids accepted.


Average yields dipped with the 182-day Treasury Bills yield declining to sit at 15.46% compared to 15.49% last week. The 364-day yield also fell to 15.80% from the 15.91% previously. However, the 91-Day bill recorded no significant change to remain at 14.79%.

The target for the upcoming auction has been set 13.78% higher at GH¢7,588.00 million. The securities on offer will include the 91-day, 182-day, and 364-day Treasury Bills.


