FIXED INCOME MARKET UPDATE GEM GOG TREASURIES

HIGHLIGHTS: The Bank of Ghana's Treasury bills auction worth GH¢2,631.00 million, was oversubscribed by 6.46%. At the end of the Auction, T-bills worth GH¢1,509.95 million, GH¢982.71 million and GH¢308.36 million were accepted across the 91-Day, 182-Day and 364-Day bills respectively.

Accepted bids equaled tendered bids, representing a 100% acceptance rate. The 91-Day and 182-Day bills recorded gains of 11bps and 1bps in their respective yields, to settle at 21.16% and 23.94% respectively. Conversely, 364-Day bills recorded a 20bps decline to settle at 27.82%

The target for the next auction (Tender #1855) is GH¢3,790.00 million for 91, 182 and 364-Day T-Bills.


