FIXED INCOME MARKET UPDATE **GFM**

HIGHLIGHTS: Last week's Treasury Bill auction was marginally oversubscribed, departing from the trend of undersubscriptions, with demand exceeding the target by 1.08%.

A total of GH¢4,613.91 million was tendered and accepted across the three T-bill maturities. The largest amount of GH¢3,887.83 million, was brought in from 91-day T-bill issuance, while the 182-day T-bills and 364-day T-bills accounted for GH¢500.68 million and GH¢225.40 million TREASURY RATES YIELD (14th Oct. 2024 - 18th Oct. 2024) respectively.

The yield on the 91-day Treasury Bills settled at 25.62%, up from 25.46%, representing a 63-bp rise compared to the 73bps decline last week. The 182-day Treasury Bills' yield also increased, sitting at 26.90% compared to 26.80% last week while 364-day Treasury Bills settled higher at 28.58% from 28.52%.

The upcoming treasury bill auction has its target set 11.61% lower at GH¢4,035.00 million. The securities on offer will include the 91-day, 182-day, and 364-day Treasury Bills.


91-Day bill , 182-Day bill & 364-Day bill




