FIXED INCOME MARKET UPDATE **GFM**

HIGHLIGHTS: At the latest Treasury auction (Tender #1981), total bids worth GH¢3.95 billion were received, of which 97.06% were accepted. The 91-day bill continued to dominate demand, accounting for GH¢2.97 billion of accepted bids, followed by the 182-day and 364-day papers at GH¢608.27 million and GH¢254.13 million, respectively.

Yields continued their upward trajectory across all maturities. The 91-day bill climbed 91 basis points to 11.03%, the 182-day advanced 39 basis points to 12.66%, while the 364-day edged up 49 basis points to 13.08%, reflecting sustained investor demand for shorter-term instruments amid tightening liquidity conditions.


Looking ahead, the upcoming auction (Tender #1982) aims to raise GH¢6.42 billion, marking a 13.01% increase in the target size compared to the previous tender. The issuance will cover the usual short-term tenors — 91-day, 182-day, and 364-day bills — and is scheduled for settlement on 24th November 2025.


91-Day bill , 182-Day bill & 364-Day bill


