# FIXED INCOME MARKET UPDATE **GFM**

**HIGHLIGHTS:** Last week's Treasury Bill auction was saw total bids falls short of the amount on offer by 16.82% being the first undersubscription since early October.

Total bids worth GH¢5,180.50 million were wholly accepted across the three T-bill maturities. The largest amount of GH¢3,942.91 million, was brought in from 91-day T-bill issuance, while the 182-day T-bills and 364-day T-bills accounted for GH¢653.43 million and GH¢584.16 million respectively.

The yield on the 91-day Treasury Bills settled at 26.97%, up from 26.83%, representing a 52-bp rise compared to the 26bps climb last week. The 182-day Treasury Bills' yield also increased, sitting at 27.79% compared to 27.68% last week while 364-day Treasury Bills settled higher at 29.22% from 29.13%.

The upcoming treasury bill auction has its target set 10.73% higher at GH¢6896.00 million. The securities on offer will include the 91-day, 182-day, and 364-day Treasury Bills.


#### 91-Day bill , 182-Day bill & 364-Day bill






