FIXED INCOME MARKET UPDATE **GFM**

HIGHLIGHTS: At the most recent Treasury auction (Tender #1991), total bids amounting to GH¢15.91 billion were submitted, with 80.47% successfully accepted. The bulk of accepted bids was concentrated in the 364-day bill, which attracted GH¢5.08 billion. This was followed by the 182-day bill, which garnered GH¢4.29 billion, while the 91-day bill accounted for GH¢3.44 billion of total accepted bids.

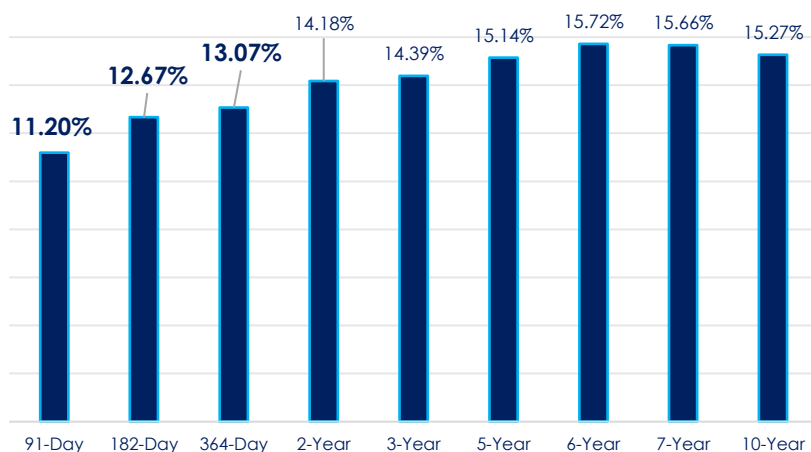
Treasury bill yields recorded broad-based increases across all maturities. The 91-day and 182-day instruments edged up by 2 basis points and 14 basis points to settle at 11.20% and 12.67%, respectively, while the 364-day bill posted a sharper rise of 65 basis points to close at 13.07%.

In the upcoming auction (Tender #1992) the treasury aims to raise GH¢6,997.00 million, marking a 28.78% decrease in the target size compared to the previous tender. The issuance will cover the 91-day, 182-day, and 364-day bills and is scheduled for settlement on 2nd February 2026.

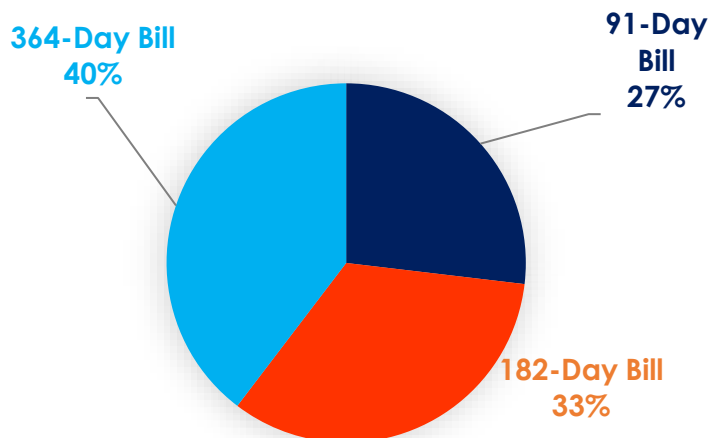
