FIXED INCOME MARKET UPDATE GEM

HIGHLIGHTS: The Bank of Ghana's Treasury bills auction worth GH¢3,206.00 million was undersubscribed by 23.83%. At the end of the Auction, T-bills worth GH¢1,419.09 million, GH¢553.42 million and GH¢468.89 million were accepted across 91-Day, 182-Day and 364-Day T-Bills auction bids respectively.

Accepted bids fell below tendered bids representing a 99.98% acceptance rate. The 91-Day and 182-Day bills recorded gains of 35bps and 17bps in their respective yields to settle at 18.88% and 21.44% respectively. However, 364-Day bills declined 116bps to settle at 25.66%.


The target for the next auction (Tender #1844) is GH¢ 1,338.00 million for 91-Day and 182-Day T-Bills.


