FIXED INCOME MARKET UPDATE **GF/M**

HIGHLIGHTS: The Central Bank upped its target by 52.65% to GH¢4,865.00 million in this week's auction, receiving GH¢749.72 million below target. Market demand for this week's treasury bills amounted to GH¢4,115.28 million, with 100% acceptance of all bids tendered. The 91-day Bill was subscribed to the most among the three tenors, followed by the 182-Day Bill and the 364-Day Bill.

Bids amounting to GH¢3,051.13 million, GH¢795.00 million, and GH¢269.15 million were accepted for the 91-Day, 182- TREASURY RATES YIELD (27th May. 2024 - 31st May. 2024) Day, and 364-Day tenors, respectively.


Average yields recorded no significant change. Yields on the 91-Day, 182-Day and 364-Day bills remained at 25.10%, 26.95% and 27.95% respectively, compared to the previous week's average rates.

For the next auction, the Central bank seeks to raise a significantly reduced GH¢2,718.00 million through the issuance of 91,182, and 364-Day bills to cover upcoming maturities of GH¢724.83 million.


91-Day bill , 182-Day bill & 364-Day bill




