- GSE attains full membership status with World Federation of Exchanges: Confidence in the Ghana Stock Exchange (GSE) from both investors and issuers has further received a major boost as the market attained full membership status with the World Federation of Exchanges (WFE). The Managing Director of GSE, Ekow Afedzie, asserts that the comprehensive scope of assessment and subsequent adherence to best practices by WFE members offers assurance to the exchanges themselves, and stakeholders who interact with them, of their commitment to the highest standards of fiduciary responsibility. - IMF to fast track economic support for Ghana: The International Monetary Fund (IMF) has assured that it will fast track processes with the Government of Ghana to provide support for the country through an economic programme. Reiterating IMF's commitment to working with Ghana, Head of the African Department, Abebe Selassie stated that the Fund put together a mission immediately after Ghana made a request for support. Mr. Selassie however added that an important part of the IMF engagement with Ghana will be providing funding to help the country. 


