
## **NEWS HEADLINES**

- \* EOCO Posts Record Recoveries in 2025, Exceeds GHS 200m Target by GHS 133.4m: In 2025, the Economic and Organised Crime Office (EOCO) achieved record recoveries of GH¢337.4 million, surpassing its target of GH¢200 million by GH¢137.4 million, as announced by Attorney-General Dr. Dominic Ayine. The recoveries include GH¢194 million in direct funds and GH¢142.4 million in indirect funds from cases concluded, demonstrating effective institutional leadership. Additionally, EOCO has recovered over US\$15 million from a cryptocurrency fraud scheme targeting Ghanaians, showcasing Ghana's commitment to combating organized cybercrime and emphasizing the importance of strong legal frameworks. Victims of the fraud will be refunded as part of this recovery effort. (Norvanreports)
- \* GWL to shut down Weija Water Treatment Plant for maintenance: Ghana Water Limited (GWL) will shut down the Weija Water Treatment Plant on December 19, 2025, from 6:00 a.m. to 6:00 p.m. for essential maintenance aimed at improving water service delivery. This temporary disruption will affect water supply in several areas of the Greater Accra Region, including Accra Central, Dansoman, and Weija. GWL's management has assured that resources have been mobilized for a swift completion and emphasized the importance of this exercise for the integrity of their water infrastructure. Customers are advised to store sufficient water in advance to mitigate the impact of the shutdown. GWL regrets any inconvenience and seeks public cooperation during this period. (Citinewsroom)


