

- \* BDCs Express Interest in Revamping TOR through Equity Stake Ownership: The Chief Executive Officer of the Ghana Chamber of Bulk Oil Distributors (CBOD), Dr. Patrick Ofori, has revealed the interest of Bulk Oil Distribution Companies (BDCs) in acquiring equity stakes in the Tema Oil Refinery (TOR). This initiative aims to support the government in revitalizing the state-owned refinery and boosting its operational efficiency. He noted that the BDCs possess the necessary partnerships and investment capital to bring TOR back online, enhancing its production capacity for both local supply and exports to neighboring countries. The BDCs propose a model where private partnerships with the government can introduce efficiency and accountability into TOR's operations. (Norvanreports)
- Limited Investments, Global Shift to Green Energy, Others Slow Recovery of Ghana's Oil Sector CBOD Report Reveals: Ghana's upstream petroleum sector experienced a slower-than-expected recovery in 2023 following the adverse effects of the COVID-19 pandemic, according to the Ghana Chamber of Bulk Oil Distributors' (CBOD) 2023 Industry Report. The report attributed the sluggish recovery to several factors, including the global shift from fossil fuels to green energy investments and programs, coupled with the relatively small sizes of Ghana's oil blocks and poor quality of exploration data.
