


- * MIIF to launch gold-backed ETF: The Minerals Income and Investment Fund (MIIF) is actively working on launching a physical gold-backed Exchange Traded Fund (ETF), set to be listed by the fourth quarter of 2024 according to MIIF's Chief Executive Officer, Edward Nana Yaw Koranteng. According to him, the ETFs will be backed by physical gold bullion held in secure vaults. Investors in these ETFs will own shares that represent a portion of the underlying gold held by the Fund. Gold for the ETF will come from MIIF's Small-Scale Gold Mining Incubation Programme, which emphasizes sustainable mining practices and traceability mechanisms to secure gold ore from licensed small-scale gold mining companies. - NPA increases price floor for diesel to GHS 13.15; petrol reduced to GHS 13.60: The National Petroleum Authority (NPA) has announced a new price floor for oil marketing companies and other players selling petroleum products from May 15 to May 31, 2024. The period covers the first pricing window for the month. The floor price for diesel has gone up to GHS 13.15, from the old price of GHC13.07. Petrol on the other hand has been reduced marginally. According to the new price floor, no oil marketing company should sell a litre of petrol below GHC13.60. The NPA also announced that a kilogram of Liquefied Petroleum Gas must not be sold less than, GHC12.30. (Myjoyonline)
