

- Parliament abolished 10% withholding tax on bet winnings, 1.5% withholding tax on unprocessed gold: Parliament on Wednesday officially approved the Income Tax Amendment Bill 2025, abolishing 10% withholding tax on bet winning as well as tax on gaming and any game of chance. The bill also abolished the 1.5% withholding tax on unprocessed gold from small-scale miners. While clarifying the intent and purpose of the bill on the floor of Parliament, Dr. Cassiel Ato Forson, the Miniter of Finance, explained that the bill defined lottery as a scheme where rights were sold to take part in a draw by lot for prize including betting, gaming and any game of chance. Therefore, the bill was not only removing withholding tax on bet winning but also gaming and game of chance. (Ghana News Agency)
- Parliament Approves Growth and Sustainability Levy Amendment Bill, Raising Mining Levy to 3%: Parliament has passed the Growth and Sustainability Levy Amendment Bill 2025, raising the levy on gold mining companies from 1% to 3% of their gross production. The amendment also extends the levy's application period to 2028. During the parliamentary debate, Finance Minister Dr. Cassiel Ato Forson defended the increase, asserting that the government must take advantage of rising gold prices to generate additional revenue for national development.
