INVESTMENT TERM OF THE WEEK

Internal Rate of Return (IRR): A financial metric used to measure the profitability of an investment that takes into account the time value of money. The IRR is not an actual dollar value of a project but a discount rate that makes the net present value of all cashflows zero in discounted cashflow analysis. In using this metric to choose between investments with similar characteristics, that with the higher IRR is usually chosen.

JUSTIFICATIONS FOR INCLUDING STOCKS IN A PORTFOLIO

- Typically, stocks outperform all other investment options over a ten-year period making them a must for long term.
- They are excellent vehicles for retirement.
- Except for a few short periods, stocks have consistently outpaced the rate of inflation.

EQUITIES MARKET UPDATE



HIGHLIGHTS: The Ghana Stock Market closed 90.21 points higher over the week, returns 14.69% YTD.

The GSE-Composite Index gained 3.33% while the GSE-Financial Stocks Index lost 2.39% over the week, bringing the year-to-date performance to 14.69% and -11.78% respectively. The market capitalization rose by 1.35% from the previous week to close at GHø68.38 billion.

This week a total of twenty-five (25) equities traded with gains of GH¢0.10 and GH¢0.03 recorded by MTNGH and TOTAL respectively. However, the week saw declines in FML, SCB and GLD, losing GH¢0.30, GH¢.90 and GH¢10.60 respectively.

A total of 162,642,512.00 shares cumulating to a value of GH¢149,027,836.40 were traded during the week. This week's data shows a 3663.42% increase in volume traded as well as a 1929.64% rise in trade turnover. MTNGH traded the most with a value of GH¢145,036,542.02 representing 97.32% of the week's traded value.
