

## Weekly Capital Market Recap: September 04, 2020

### Stock Market Highlights

- The benchmark index declined by 0.38% due to losses in two counters in the banking and consumer goods sectors. The GSE-CI closed at 1,840.07 with a -18.48% year-to-date return while market capitalization declined by 0.21% to settle at GH¢52.46 billion.
- The GSE Financial Index was flat all week, closing at 1,687.40 with a -16.45% year-to-date return.

### Total Value Traded Declined

- A total of 9,585,953 shares valued at GH¢7,661,028 changed hands this week compared to 3,785,737 shares valued at GH¢7,750,151 last week.
- Fan Milk Ghana Limited** dominated trading activity, accounting for 61.40% of total value traded.

### Outlook

- We expect a slowdown in trading activity next week due to the coronavirus outbreak.

### Ecobank Ghana Limited (EGH)

EGH has announced the resignation of Mr. Martin Eson-Benjamin and Mrs. Rosemary Yeboah, Non-Executive Directors, from the Bank's Board, effective 10th day of August 2020.

### Fixed Income Market Highlights

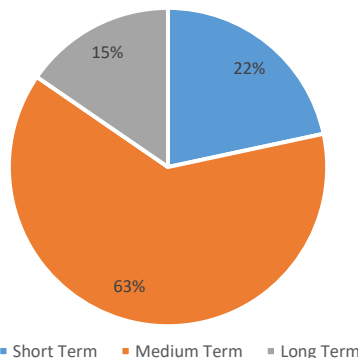
#### Primary Market

- Investors bought 98.61% of treasury securities offered today. GoG accepted GH¢1,026.57 million in exchange for treasuries, marginally lower than the target of GH¢1,041 million. A total of GH¢900.65 million was raised in 91 day bills, GH¢70.93 million in 182 day bills and GH¢54.99 million in 364 day bills compared to GH¢699.06 million in 91 day bills and GH¢107.88 million in 182 day bills last week.
- The yield of the 91 day bill narrowed by 4 bps from 14.06% to 14.02% last week while the average yield of the 182 day bill widened by 3 bps to 14.11%. The 364 day bill sold at a yield of 16.91%.
- The target for the next auction is GH¢919 million in 91 and 182 day bills.

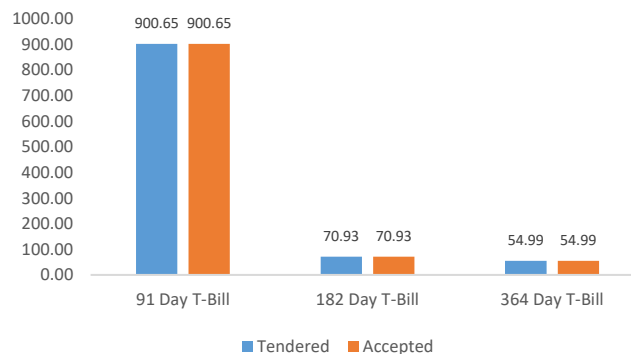
#### Secondary Market

- Securities maturing in the medium term (2 – 10 years) continue to drive trading activity, accounting for 63% (last week: 84%) of trades while securities with short term maturities (less than 2 years) accounted for 22% of trades.

### Weekly Auction for 4<sup>th</sup> September, 2020 (GH¢ mn)

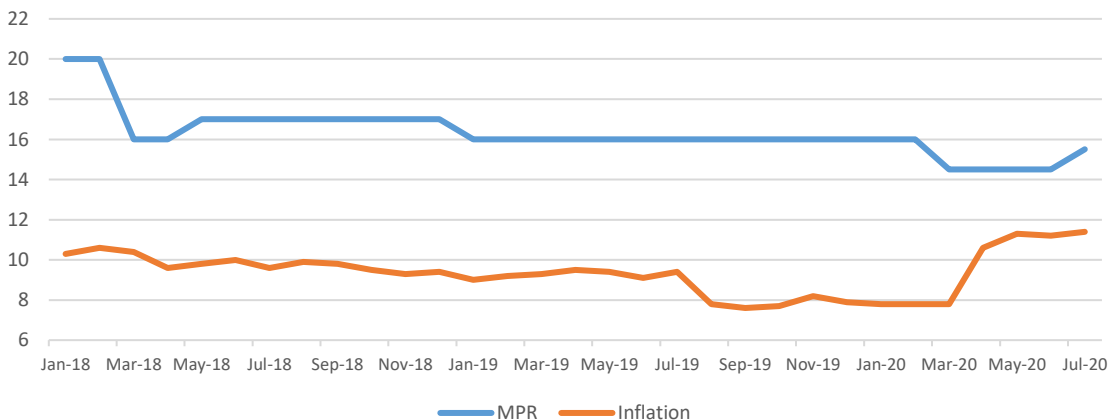
